

## **THE CHILD SAFE/CHILD PROTECTION POLICY FOR Home Education WA**

This Child Safety Policy has been adopted by LEAP East Victoria Park

This policy demonstrates the strong commitment of the organiser(s), instructors and volunteers to child safety and establishing and maintaining child safe and child friendly environments.

### **Commitment to safety of young people**

All young people who access the services of the LEAP East Victoria Park have a right to feel and be safe.

LEAP East Victoria Park are committed to the safety and wellbeing of all children and young people accessing our services and the welfare of the children in our care will always be our first priority. We aim to create a child safe and child friendly environment where young people feel safe and enjoy learning.

***Where personal contact is required as part of the training provided, the appropriate procedures will be explained to the young person prior to the training being undertaken.***

### **Scope**

This policy applies to all instructors, volunteers, young people, visitors and members who access the services of LEAP East Victoria Park..

### **Young people's rights to safety and participation**

LEAP East Victoria Park, instructors and volunteers encourage young people to express their views, and make suggestions, especially on matters that directly affect young people. We encourage all young people who access our services to 'have a say' about those things that are important to them. We value diversity and do not tolerate any discriminatory practices.

We advise young people about what they can do if they feel unsafe. We listen to and act on any concerns young people, or their parents, raise with us.

## **Recruitment of employees and volunteers**

LEAP East Victoria Park will be diligent in the recruitment and screening of instructors and volunteers. Our statement of commitment to child safety and our requirements are included in all advertisements.

The LEAP East Victoria Park conduct criminal history assessments for people working with children, as required by [Working with Children \(Criminal Record Checking\) Act 2004](#) and subsequent amendments.

## **Support for instructors and volunteers**

LEAP East Victoria Park seeks to attract and retain the best instructors and volunteers. We provide support and supervision so people feel valued, respected and fairly treated. LEAP East Victoria Park have a code of conduct to provide guidance to our instructors and volunteers, all of whom acknowledge the requirements of the code. We also have a grievance procedure so that we can ensure that all issues raised can be addressed in a fair and equitable matter.

## **Reporting and responding to suspected abuse and neglect**

LEAP East Victoria Park will not tolerate incidents of child abuse.

LEAP East Victoria Park are responsible for ensuring that instructors and volunteers are aware how to make appropriate reports of abuse.

**Instructors and volunteers must notify the Department of Child Protection 1 800 622 258 as soon as practicable if they have a reasonable suspicion that a young person has been or is being abused or neglected.**

A person does not necessarily exhaust his or her duty of care to a child by making a report to the Department of Child Protection – they may still have a role in supporting the child or young person. For example, instructors and volunteers may also report any form of abuse to [\*\*HEWA\*\*](#) for further support or to ensure that LEAP East Victoria Park take all reasonable steps to keep the child and others safe.

LEAP East Victoria Park will support any instructor or volunteer that makes a report to the Department of Child Protection.

The Child Protection contact is the group Organiser.

## **Related Policies and Procedures**

The following policies and procedures also support LEAP East Victoria Park child safe policy:

## THE CHILD SAFE/CHILD PROTECTION POLICY

### DEFINITIONS

*Child (Young person)* – A child means a person under 18 years of age

*Child Abuse* – Children can be abused in different ways and child abuse includes a wide range of acts of omission and commission.

*Physical Abuse* – is commonly characterized by physical injury resulting from practices such as hitting, punching, kicking (marks from belt buckles, fingers); shaking (particularly young babies); burning (irons, cigarettes), biting, pulling out hair; alcohol or other drug administration.

*Sexual Abuse* – occurs when someone in a position of power to the child uses his/her power to involve the child in sexual activity. Behaviour can include sexual suggestion; exhibitionism, mutual masturbation, oral sex; showing pornographic material e.g. DVDs, internet; using children in the production of pornographic material; penile or other penetration of the genital or anal region; child prostitution.

*Emotional Abuse* – tends to be a chronic behavioural pattern directed at a child whereby a child's self esteem and social competence are undermined or eroded over time. Behaviours may include devaluing, ignoring, rejecting, corrupting, isolating, terrorising, chronic or extreme domestic violence in the children's presence.

*Neglect* – is characterized by the failure to provide for the child's basic needs. Behaviours may include inadequate supervision of young children for long periods of time; failure to provide adequate nutrition, clothing or personal hygiene; failure to provide needed or appropriate health care/medical treatment; disregard for potential hazards in the home; forcing the child to leave home early; allowing children to engage in chronic truancy.

*Child Protection Contact Person* – the Organiser(s) to be responsible for child protection matters and to ensure that LEAP East Victoria Park child protection procedures conform to the requirements of the relevant jurisdiction.

*Criminal history assessment:* a decision about whether a person is suitable to work with children based on the person's criminal history (if any) and the assessed risk of harm to children who receive the service.

*Instructor* – any person over the age of 18 who is contracted by LEAP East Victoria Park and is responsible for the care and safety of children in a recognised training course delivered under the LEAP East Victoria Park.

*Young person* – term used instead of the word child to describe a person under the age of 18.
